





Test Method</p> <p>Bioequivalence studies should be performed by single dose studies in both the fasted and fed states. <u>In the case of postprandial administration, a high fat diet of 900 kcal or more containing 35% lipid content should be used.</u> The meal should be eaten within 20 min, and drugs administered within 10 min thereafter.</p> <p>When a high incidence of severe adverse events is indicated after dosing in the fasting state, the fasting dose studies can be replaced with postprandial dose studies with the low fat meal employed in the study for oral immediate release products and enteric-coated products. Test Method</p> <p>Bioequivalence studies should be performed by single dose studies in both the fasted and fed states. <u>In the fed study, a high fat diet of 900 kcal or more and calories from fat exceeding more than 35% of total calories.</u> The meal should be eaten within 20 min, and drugs administered within 10 min thereafter.</p> <p>When a high incidence of severe adverse events is indicated after dosing in the fasting state, the fasting dose studies can be replaced with postprandial dose studies with the low fat meal employed in the study for oral immediate release products and enteric-coated products. Other testing conditions should follow those of oral immediate release products and enteric-coated products. (略)</p>
